

Terms and Conditions Lustrum Holiday



To enjoy a pleasant and safe holiday together

Ticket condition

- ❖ Children under the age of 15 are not permitted on this trip without the express permission of the LPR travel guides. In turn, the guides require permission from the board of Les Précieuses Ridicules.
- ❖ All persons under the age of 18 require written consent from their parent(s)/guardian(s) in order to be allowed on this trip (abroad).
- ❖ The ticket is registered to a specific person, is personal and is non-transferable.
- ❖ Reselling the ticket at your own initiative is not permitted. Under the cancellation policy, you may sometimes be able to resell your ticket via LPR.
- ❖ Whenever the travel guides clearly state they will be taking photos intended for publication, it is up to you to ensure that you are not in these photos if you do not wish to be.

Included in the ticket

- ❖ A stay at Chateau Thermes de Cugnon from Monday 13 July 2026 to Monday 20 July 2026, taking into account the check-in and check-out times as communicated by the LPR travel guides in the week before departure.
- ❖ Transport by car/minibus from Nijmegen to Chateau Thermes de Cugnon and back on the arrival and departure dates respectively. (Travel from other cities will be facilitated as much as possible, but cannot be guaranteed.)
- ❖ A basic breakfast, lunch and dinner, including basic non-alcoholic beverage options. You are not obliged to make use of this (every day), but you won't receive a (partial) refund if you don't make use of it on some or all days.
- ❖ Free entrance to the dance party in the ballroom on Saturday 18 July 2026.

Additional options (at your own expense)

- ❖ It is possible to participate in centrally organised activities during this anniversary holiday. These are all optional, so participation is not mandatory. If there are additional costs associated with these activities, these are always made at your own expense. As the holiday approaches, the LPR travel guides will indicate when you can book an additional activity and under what conditions (if any).
- ❖ If you have or know someone with a car, you can explore the local area. The associated petrol costs are always at your own expense, unless the LPR travel guides ask you to do something for them and explicitly offer compensation in return. The same applies to any entrance tickets for local attractions/outings.
- ❖ We are going to Belgium on this trip. Travel insurance is not included in your ticket. Travel insurance is not legally required (at least not for Dutch citizens), but it may be a good idea to take out temporary travel insurance if you are not continuously insured. The main reason for this is to avoid unexpected — often high — medical costs.

Payment and petrol/charging allowance

- ❖ The ticket price is €300.- (all-inclusive). At the moment the ticket is purchased, a minimum of €100.- must be paid. This payment is, in principle, non-refundable.
- ❖ If you choose to pay in two instalments, the remaining €200.- must be paid by 30 April 2026 at the latest. It is also possible to pay the full ticket price at once when purchasing the ticket.
- ❖ If you act as a driver, you are eligible for a petrol/charging allowance of €140.-*, based on the following assumptions:
 - Your car/minibus can move at least 4 people (including the driver) and their luggage;
 - You will be driving from and back to Nijmegen OR from an alternative location approved by the travel guides.

** If you can transport more than 4 people and/or you can shuttle people beyond Nijmegen, this amount may be increased in consultation with the LPR travel guides. If you can transport fewer than 4 people, LPR is entitled to reduce the allowance proportionally.*

Annuleren en restitutie

- ❖ If you cancel your ticket, the €100.- deposit remains, in principle, non-refundable. The LPR travel guides are entitled to make exceptions to this rule at their own discretion.
- ❖ If you cancel your ticket, the LPR travel guides will try to resell your ticket. This is only possible if all tickets are sold out and there is someone on the ticket waiting list.
 - If the ticket can be resold, the remaining sum of €200.- will be waived or refunded.
 - If the ticket cannot be resold, you will remain liable for the full ticket price, which must be paid in full by 30 April 2026 at the latest. The LPR travel guides are entitled to make exceptions to this rule at their own discretion.
- ❖ You can request a resale from the LPR travel guides by sending an email to lusco@hofdansen.nl, addressed to TG Vakantie.
- ❖ If the entire trip has to be cancelled due to *force majeure* on the part of LPR or Chateau Thermes de Cugnon, no part of the ticket will be refunded. Any additional costs incurred in preparation for the trip will also not be refunded in such an event. (Examples of *force majeure* include: severe weather, lockdowns and (severe) fire or water damage to the castle, among other things.)

House rules

- ❖ Listen to the LPR travel guides and the Chateau staff. Follow their instructions carefully.
- ❖ Open fires are not permitted anywhere on the premises, except in the designated fire pits.
- ❖ Smoking, vaping, etc. is strictly prohibited in all indoor areas of the Chateau and associated buildings and is only permitted outdoors at a suitable distance from the buildings and shrubs.
- ❖ Drug use of any kind is strictly prohibited.
- ❖ Alcohol may be consumed on the premises, but please drink in moderation. We will adhere to Dutch drinking laws, so you must be at least 18 years old to purchase, possess and consume alcohol. Drunkenness will not be tolerated.
- ❖ The sale or resale of cigarettes, drugs or alcohol on the premises is also prohibited.
- ❖ Pets are not allowed.

- ❖ You may only sleep in the bed/room assigned to you. Swapping rooms is only permitted after consultation with the travel guides, and visiting another bedroom is only permitted with the permission of the people sleeping in that room.
- ❖ You may not receive guests of any kind in your room or elsewhere on the premises who have not been approved (in advance) and registered with the Chateau by the LPR travel guides.
- ❖ Show respect to the local villagers and be considerate of the Chateau's neighbours. This means, among other things, that you must not cause any nuisance or disturbance to the neighbourhood. Use your common sense to determine what this entails.
- ❖ Also show respect to your fellow holidaymakers. Adhere to the LPR code of conduct and help to leave the Chateau clean and intact, both during and after our stay. Carry out any chores you are assigned neatly, completely and in a timely fashion.
- ❖ You may not take photos of people without their permission and/or post them on social media: always ask the people in the photo for permission. Taking photos for your own use (i.e. not for commercial purposes/posting on social media) is, of course, allowed.
- ❖ You may bring your own speaker to play music. Keep in mind that this music should not disturb the neighbours or your fellow holidaymakers. Outside, only background music may be played until 22:00 (10 p.m.). Inside, music may be a little louder. On the ground floor, soft music is still allowed until 01.00 (1 a.m.), but it must not be heard at all outside or upstairs.
 - In the party room, only the music system provided may be used. Music may be played here until 01.00 (1 a.m.).
- ❖ Dance parties are not allowed indoors due to possible damage to the antique floors. Dancing is allowed outside on the terrace.
- ❖ Do not destroy/damage items that do not belong to you. Vandalism will be punished with a fine equal to all costs charged to LPR in connection with the damage caused and its ensuing repair, including processing costs if applicable.
- ❖ The spa building is open from 10:00 - 21:00 (10 a.m. to 9 p.m.) and is intended as a relaxation area. You enter/use it at your own risk. Before using the spa building, you are required to carefully read the instructions regarding its use, as well as that of the jacuzzis. Persons under the age of 18 are not allowed to enter or use the spa building without adult supervision. If this does happen, the thermal baths will be permanently closed off for the rest of our stay there.
- ❖ The playground and trampoline are provided for the entertainment of children. Adults are not permitted to use the swings, slide, etc. The trampoline may be used, but always without shoes and only by one adult at a time.

Additional stipulations

- ❖ If the LPR travel guides observe or learn that one or more rules have been violated, they are entitled to impose appropriate consequences. In the worst case, this may include an immediate return ticket home at the offender's own expense. If they deem it necessary to report the matter to the police, they will do so (as well).
- ❖ Neither LPR, nor the tour guide, nor Chateau Thermes de Cugnon accept any liability for theft, loss or damage — of any kind — to personal property during or as a result of a stay at the Chateau, nor are they liable for personal injury to you or others that is not caused by their direct influence.
